Now, the Tafts are laying the foundation for a brighter future for the Preserve by generously supporting The Nature Conservancy's Silver Creek Enhancement Plan—a five-year project benefitting both people and nature. The Tafts' lead gift makes possible a key element of the enhancement

plan: a major renovation to the Preserve's Visitor Center, featuring an expanded facility with a new classroom and other essential upgrades.

Reimagining Silver Creek Preserve



Idaho is a state carved of rugged peaks and raging whitewater, so perhaps it is the still, tranquil nature of Silver Creek Preserve that takes our collective breath away. For over four decades, The Nature Conservancy has worked to restore Silver Creek's high-desert spring and protect its inspiring natural qualities from development with generous support from our donors and community.

But now, a confluence of threats has placed Silver Creek in jeopardy. An increasingly unreliable snowpack means less dependable flows and higher stream temperatures, threatening the health of the fishery. The ageing infrastructure no longer meets the needs of visitors. And the lack of educational programming prevents opportunities to engage visitors in critical conversations about conservation, climate change and the relationship between people and nature.

That's why TNC launched the Silver Creek Enhancement Plan to ensure the health and vitality of the Preserve and protect its important role in the region's economy, watershed and community. The enhancement project will restore a greater variety of habitat for fish that meets the needs of their various life stages. It will create a community space that educates, inspires and serves our community and youth. And it will provide safer, more accessible ways for people of all ages and abilities to delight in, learn from and engage with this special place.

Thank you for being a part of this legacy. We look forward to enjoying the next chapter of Silver Creek with all of you.

Science-Driven Restoration

Conservation and stewardship have been the heart of TNC's work at Silver Creek since 1976. The conservation priorities of the enhancement will focus on revitalizing Silver Creek's aquatic ecosystem through actions that restore stream function, boost water supply, enhance aquatic habitats and expand riparian buffers. "We are actively collaborating with our partners and local stakeholders to restore Silver Creek and its tributaries," says Erika Phillips, Silver Creek's watershed manager. "Our goal is to improve the resiliency of this diverse, spring-fed aquatic ecosystem and its wild trout fishery, while also demonstrating the value of science-based restoration techniques and community-based solutions." This effort will also include implementing first-of-their-kind water market mechanisms, irrigation infrastructure efficiency projects and projects to improve channel conditions.







Infrastructure Improvements

TNC strives to provide a positive experience at Silver Creek Preserve where visitors can experience first-hand the benefits of conservation. In November 2020, Blaine County approved a Conditional Use Permit and a Site Alteration Permit to expand the existing Silver Creek Visitor Center. This expansion will add a 1,422 square foot classroom suitable for approximately 25 students and other community events, with construction expected to begin in 2021. Investing in facility improvements will ensure that the Preserve remains a beloved public resource and an inspiration for community-based conservation. The project will also include accessibility improvements to existing trails and boardwalks and additional fishing access structures like steps and ramps. This will help provide safe entry locations for anglers while also protecting riparian and streambank resources.

Inspiring the Next Generation

The long-term success of our work today depends on cultivating the next generation of environmental conservationists and advocates. By concentrating efforts to expand outreach and educational programs at Silver Creek, the Preserve will be a catalyst for empowering youth and community members to be active conservation ambassadors. This will be accomplished by providing on-site educational activities for field trips, family-focused events, self-guided tours and summer internships. Our new programming will be developed with community input, including from local educators. Through these new opportunities, TNC envisions Silver Creek as a place where students, educators and volunteers will foster and strengthen the values that lead to deep personal commitments to conservation.
