# Why Purchase Credits from The Nature Conservancy?

#### **Reduced Permitting Time**

- Mitigation utilizing an in-lieu fee program has resulted in an average of 50 days to complete permits versus permitteeresponsible mitigation which averages permitting times of 90-300 days
- Statewide stream and wetland credit availability allows one-stop shopping for mitigation needs

#### **Economically Advantageous**

- No down payment required to reserve credits
- No requirements for maintenance, monitoring or long-term management


#### **Transfer Obligations and Liability**

- Many small projects required for permittee-responsible mitigation often fail and require ongoing restoration and long-term management—resulting in 5-10 years of obligations
- Buying credits from the Conservancy means permittee obligations end once payment is made
- The Conservancy maintains a Contingency Fund that helps ensure a 100% restoration success rate

## The Preferred Ecological Alternative

The Conservancy consolidates money from many small permitted impacts to complete well-designed and strategically located projects that have a high chance of ecological success.

# How to Purchase Stream and Wetland Credits

- Contact the Conservancy to inquire about credit availability
- Submit Credit Request Form to the Conservancy (no down payment required)
- Receive Credit Reservation Letter
- Use Reservation Letter in 401 and 404 permit applications
- Purchase credits once the permit is issued



### **Once Credits are Purchased**

The Conservancy assumes the mitigation obligation from the permittee. The Conservancy then identifies restoration sites and hires environmental consultants for the design and implementation.
