Chester Butler - difficult to determine the distance between the shoreline and the breakwaters.

Jeff – It's shallow and less than 1,000 feet from the existing shoreline.

Chris - lots of other great projects to choose from.

Bob – Lighting point is a great bird attraction and has provided excellent public access to a low-income community – BLB.

Darryl – mentioned another project and differences between projects depending on depth and other features and what you are trying to accomplish.











Chester – that's the largest project he's seen but likes it if it works.

Darryl added that PEB was kicking off 6.5 miles of shoreline.

Chester – in talking to landowners along the shoreline it's very difficult how effective these things contrast with typical bulkheads. People spend a lot of money on walls that get eroded and he shows people, but they still don't understand.

Darryl mentioned the domino effect of seawalls causing erosion, and then added the SLR benefits of natural shorelines.

Rick Durbrow – in the study what were you looking at – species/ecosystem types and gave the example of Longleaf pine vs. other types of pine/trees? Kiera mentioned the data and that they looked at 'trees' as a cover type/in aggregate; did not look at specific tree species.

Anita Grove – ANERR has 7 living shorelines now of varying designs. Holding pretty good and have some good data. Some could use more funding to broaden. County is working on a beach renourishment and dune project – they might have funding but not sure. City of Apalachicola has 2 large pervious pavement projects and a culvert sizing study but the project hasn't been funded. Quick project summary.

ARPC Josh Adams – between Eastpoint and Carabelle beach they have a 12 mile stretch of shoreline project to create about 20 acres of reef and 30 acres of marsh through GEBF NFWF.

Bob asked what stage – waiting on the permits. Difficult permitting process with State Lands and they estimate going to construction Spring 2022.

Jim Muller – what is the extent – Sandy area to the west of Carabelle all the way to the breakwater in Eastpoint. Homeowners sometimes want sandy beach and they are not doing that part of the project. Chester brought up future flooding – Josh mentioned that area is accreting shoreline.

Jim Muller - Tyndall AFB was awarded to do living shorelines through TNC.
